- 5. Disclosing to outside parties plans and other information about the Foundation when such information is not readily available to the general public.
- 6. Leveraging involvement with the Foundation to secure favorable rates, discounts, or other preferential treatment.
- 7. Profiting materially through consulting or other activities predicated on skills and knowledge gained through association with the Foundation.

The Foundation acknowledges that the appearance of conflict of interest does not always imply actual conflict. Policy requires, therefore, that all potential conflict of interest—including membership in or affiliations with other nonprofit or proprietary organizations, business affiliations, with possible vendor implications, elected office at any level, and involvement in other activity that might be construed in conflict with the mission and goals of the Foundation—shall be presented in writing to the Foundation's Chair for review and approval/disapproval.
