### I. PURPOSE:

The Technical College System of Georgia (TCSG) is committed to assisting each student to achieve their maximum potential. All students applying to a Technical College will be admitted after satisfying one of the Academic Criteria listed in this procedure. Students will then be advised and allowed to register in accordance with the academic standards applicable to their chosen program.

Per the Statement of Equal Opportunity, the System and its constituent Technical Colleges will not discriminate in admissions.

### III. APPLICABILITY:

All work units and Technical Colleges governed by the Technical College System of Georgia

### IV. DEFINITIONS:

**Admissions Process:** Admission to a Technical College System of Georgia college is a process that consists of an evaluation of the prior academic experience.

**Eligible Applicants:** Individuals 16 years or older or dually/jointly enrolled high school students in the 9th, 10th, 11th, or 12th grades who seek access to quality instruction at the postsecondary level.

**VI. PROCEDURE:**

A. Required Academic Criteria

1. To be admitted by all Technical Colleges, applicants must satisfy one of the six academic readiness paths below:
  - a. High school graduation must verify a student has met attendance, academic, and/or assessment requirements for the state's Board of Education or equivalent agency.
    - i. High school diplomas/transcripts must be issued from a state-recognized secondary institution.
    - ii. Applicants with diplomas from secondary schools outside the United States must have their transcripts translated and evaluated for equivalency by an approved outside evaluation organization.
    - iii. High school Certificates of Attendance or other certificates, credentials, or documents where the student did not complete all required coursework or testing required for a high school diploma in that state are only recognized for programs not requiring a high school credential or equivalency.
    - iv. Georgia Match students who secure their spot through the Georgia Student Finance Commission (GSFC) portal can be admitted under a Pending placement status.
  - b. Submission of an official transcript reflecting that the student has passed an examination or completed a program the state recognizes as the equivalent of a high school diploma (e.g., GED, HiSET, Career Plus HSE).
  - c. Exceptions to requirements 1 or 2 include those students seeking enrollment into an approved basic workforce certificate that does not require a high school diploma or high school equivalency for admission, as listed in the Attachment 6.2.1p.a2 Program Placement Information viewable in procedure 6.2.1p2. Placement Requirements.
  - d. Submission of an official transcript from one or more previously attended postsecondary institutions (accredited by an accepted accrediting agency) reflecting the successful completion of a minimum of 12 semester or 18 quarter credit hours of coursework at the postsecondary level or successful completion of a college level math and English course.
    - a. Applicants who were home schooled and who attended an accredited program must submit:

- annual progress reports or a final transcript for the equivalent of the homeschooled student's junior and senior years;
  - The final progress report or transcript must include the graduation date.
- b. Applicants who attended a non-accredited high school or home school must submit an official transcript and one of the following:
  - Official scores from an assessment instrument meeting college established required minimums per Attachment 6.2.1a2
  - Successful completion of 12 hours of college coursework for credit that appear on an official college transcript

2. Service members of the U.S. Air Force, Army, Coast Guard, Marines, Navy, and Space Force may submit an official copy of their DD Form 214 or other official documentation of military service indicating high school graduate or equivalent.
3. Exception: Presidents of Technical Colleges may waive the high school diploma/high school equivalency requirement for those pursuing a high school equivalency who are otherwise eligible to enroll in a specific program of study. Presidents of Technical Colleges have the authority to exempt students from the requirement of submitting all prior college transcripts if they seek to waive transfer credits for some or all previous institutions. Presidents may waive the high school diploma/high school equivalency requirement for individuals participating in a TCSG approved workforce development course/cohort.

## **VII. RECORDS RETENTION:**

All records shall be maintained per the Georgia Records Retention Schedule maintained by the Georgia Archives, University System of Georgia.

TCSG only accepts high school diplomas from secondary schools accredited by one of the following accreditation agencies. Acceptable accreditation must be in place when the diploma was granted. The following agencies are approved:
